




Daring to do the difficult is exploring the world of greatness.

Congratulations to all the members of San Jose Multi-purpose Cooperative for our 55th General Assembly.

It's already five (5) years after we celebrated our Golden Jubilee. SJMPC continues to fly high, providing quality and responsive services to both male and female members. We were awarded as the CDA Regional Awardee for 2018 – Millionaire Coop Category. We were also recognized in our contribution to the economic development of the Antiqueños thru the Bugal kang Antique Awards 2018 for Entrepreneurship.

Our theme for this year: "Disiplinado nga Miyembro, Benepisyo Sigurado" gives importance to quality membership. We believe that taking care of our members to become active and responsible are key to the success of our cooperative.

In 2018, we were able to give a total of PhP2.7M as discounts for advance payment of loans. This immediate benefit has encouraged more and more borrowers to pay their loans ahead of schedule. Every year, we also achieve a record breaking performance. As of December 2018, our surplus was the highest and our Portfolio at Risk (PAR) is 8.74%, the lowest so far. Loans which have missed payments for less than a year is backed up by 44% allowance, much higher than the 35% required by CDA. While loans unpaid for over a year have 100% allowance. The effective internal fund generation has resulted to Zero external borrowing for more than a decade already. This year, we will be offering more saving products to respond to various needs of the members.

We are grateful for your continuing trust and support as owners of our cooperative. We are also thankful for our dedicated frontliners and committed officers who work as a team to reach beyond our target.

We assure you that our cooperative is operating with high sense of accountability, transparency and fairness. We ensure that staff and officers are updated in their obligations to serve as models to our members. We want every member to be proud that they belong to San Jose MPC family!

Villavert Evangelio, the financial statements of San Jose Multi-Purpose Cooperative which comprise the Statements of Financial Conditions as of December 31, 2017 and 2016, Statements of Operation, Statements of Changes in Equity and Statements of Cash Flows for the years then ended, and a summary of significant accounting policies and other explanatory notes. The financial statements present fairly, in all material respects, the financial position of SJMPC as of December 31, 2017 and 2016, and the results of its operations, changes in equity and cash flows for the years then ended in accordance with the Philippine Financial Reporting Standards applicable to Cooperatives in the Philippines, taking into consideration Cooperative laws, rules, principles and practices.

- 5. The committee, through the General Manager Mrs. Rodelyn Vera Cruz -Berto, was made aware of the CDA required trainings scheduled in April to June 2018. The committee then tried to reach out to potential METV members who are interested to join the trainings and who will be qualified to run for elective positions at SJMPC. The committee also asked the Management to post in its social media account the EleCom information regarding the CDA required trainings for interested METV members.
- 6. The committee joined the Area Coordinators' monthly meeting for April and May and campaigned for METV participants for CDA required trainings. On December 29, 2018, the EleCom disseminated information with the ACs regarding the SJMPC Election on March 24, 2019 during the General Assembly.
- 7. The Committee organized and completed EleCom files in compliance with the memo issued by BOD Chairperson, Mrs. Marilou R. Llavan.
- 8. The EleCom members also attended the following Coop activities:

- 9. The committee during one of its meetings reviewed the information/guidelines regarding the adoption of the representative assembly. The committee relayed to the BOD the inputs and the initial outputs of the recent training on the Cooperative Election Rules Formulation. The EleCom realized that SJMPC doesn't have a comprehensive Election Manual that should include the Election Code and other sections necessary to administer its annual election activities. The following are concerns that should be clearly stated in the Election Manual:
 - a. If a member of the EleCom decides to run for election during its term, the member must tender resignation letter addressed to the BOD not later than thirty days before the last BOD meeting.
 - b. In any case when during the General Assembly Election and if the composition of the EleCom is incomplete, the BOD can appoint any member of the SJMPC to complete the membership and assist the EleCom in the conduct of election in an interim capacity.
 - c. The EleCom shall appoint Election Tellers (from the Area Coordinators, staff, officers and other SJMPC members) for every election to facilitate the electoral process. The principal role of the Election Tellers is to assist the METV during the elections.
 - d. The Election Rules and Guidelines adopted by SJMPC should include mandatory training requirements for the officers.
 - e. The Calendar of Activities (Timeline) shall be included in the Election Manual i.e. conduct of monthly meeting.
- 10. The EleCom request the BOD to follow them to attend the National EleCom Summit to help them understand and weigh if SJMPC will pursue the Representative Assembly or to use the automated system for the yearly election.

GENDER And DEVELOPMENT (GAD) COMMITTEE

For 2018, the Committee has accomplished the following:

- 3. GAD and Family Enrichment Seminar conducted on September 8, 2018 with Ms. Norma Pereyras, former Chairperson of Tagum Cooperative and an International Development Educator of Asia as the Resource Person; participated by the Board of Directors, Management Staff, and various Committees
- CDA's Gender Equality (GE) Assessment Tool accomplished which helped identify SJMPC's strengths and areas
 for improvement
- 5. Men's Health Awareness Forum Conducted which focused on Prostate Problem, with Dr. Marjohn Morano, the only Urologist in the Province of Antique as Speaker, which was participated by 125 individuals
- 6. SJMPC is now a member of the Gender and Development Inter-Agency Committee (GAD IAC) of the Province of Antique and has partnered with Antique Human Development Program, Inc. (AHDP) for its GAD-related programs

MANAGEMENT REPORT

Fifty Five years ago, SJMPC's vision was to uplift the lives of the Antiqueños particularly emancipating them from abject poverty. Today, SJMPC has been contributing to the growth of economy not just in the province of Antique but in the nearby towns of Iloilo particularly Oton and Miagao. The Cooperative is committed to pursue its Vision and Mission and live out its Core Values highlighted by the following in 2018:

1. MEMBERSHIP

SJMPC recognizes the prime importance of people in the organization. The members have an indispensable role in the Cooperative. Hence, SJMPC targeted to recruit more members the areas where it operates. For this year, there were 1,138 new members for the year from the various offices of San Jose, Miagao and Oton. Today, San Jose Multi – Purpose Cooperative has a total members of 11,190. Sixty Nine percent (69%) are female and Thirty Percent (31%) are male.

As to classification, 8,214 or73% of these are Active members, 1,974or 18% are Delinquent Members and 1,002 or 9% are Dormant.

Since SJMPC is advocating Gender Equality, recruitment of male members is its priority.

2. GAAN PROGRAM

The SJMPC Damayan Program which began in the 1970s with the aim of lessening the burden of the bereaved families has gained popularity and usefulness among members. Five years ago, only 50% of the members joined the program. Today, 86.35% of the total members joined the GAAN Program. So far, it has assisted 42 families and a total ₱778,000.00 has been given to them as assistance.

This year, SJMPC partnered with FONUS which gave bereaved families a ₱5,000 discount in wake and funeral services.

3. CREDIT and SAVINGS

The financial assistance was used by members for their children's educational needs, house repair, business capital and others.

Financial Literacy has been formally integrated in the PMES Module in 2017. Averagely, Deposit Liabilities increased by ₱30M for the last 5 years and Savings and Time Deposits increased by ₱46M. This shows that members are now more aware of savings.

4. NET SURPLUS

Ordinarily, Net Surplus is the gauge how a certain business is doing, measuring the capacity of an enterprise to give returns to its investors and patronizers. In the Cooperative, vigilant members always monitor the net surplus of the cooperative because 70% goes back to them through the Dividend and Patronage Refund. For the past 5 years, increase in net surplus ranges from P2 to P3M annually. For 2018, net surplus increased by ₱5.9M or 21% from last year, reaching ₱33.9M.

5. ASSETS and PAID-UP CAPITAL

SJMPC's assets as of December 2018 increased by 20% yielding total assets to ₱450.5M.

6. REBATES

For four (4) years now, SJMPC immediately reward members who paid their loan due on time. They are given 10% rebates of their total interest paid and is credited to their respective share capital and savings deposits. Rebates are increasing from 2014 until the present. As of December 2018, total rebates granted to members amounted to P2.7M.

7. SOCIAL ACTIVITIES

San Jose MPC recognizes its social responsibility to its members and the communities where it operates. For the year, the following social activities and programs were realized by the Cooperative spearheaded by its Social Services and Development Committee:

- b. Sponsorship of Mass Wedding for 20 couples
- c. Supplemental Feeding and Coop Brigada Eskwela in various schools

- i. Senior Citizens Day


8. AWARDS and RECOGNITION

SJMPC: Journeying towards a Brighter Antique and Panay

Kruuuuuhay!!!

San Jose Multi-Purpose Cooperative (SJMPC) was established in 1964 with the help of the Mill Hill Missionaries headed by the first Bishop of Antique, Msgr. Cornelius De Wit, with a vision of uplifting the lives of Antiqueños, particularly emancipating them from abject poverty. It was registered with the Cooperative Administration Office on September 24, 1964 as "San Jose Credit Union." It started with an initial share capital of P4,288 and only covers the municipality of San Jose de Buenavista.

In 1995, San Jose Credit Union was registered as "San Jose Multi Purpose Cooperative" and was re-registered in 2009, now covering the entire Panay Island, with the passing of RA 9520 or the Cooperative Code of the Philippines.

Today, SJMPC has total assets of P434M and a share capital of P147M. Its membership soared to 11,221 from its 3 offices – the San Jose Main Office at Trade Town, Dalipe, San Jose, Antique, and 2 satellite offices in Oton, Iloilo, and Miag-ao, Iloilo.

Our Vision for SJMPC is a responsive, dynamic, self-reliant and transparent cooperative, providing quality service or business, and caring for the environment towards a better life in Panay Island. SJMPC is committed to do its Mission, namely:

- a) As Financial Intermediary Institution provides friendly, affordable, accessible financial services towards building financially disciplined and empowered members;
- As People's Movement raises the level of social and political consciousness of the members on participative governance thru continuous information, education and communication processes geared towards a responsive and responsible community;
- As social Development Institution instills the values of honesty, openness, industry, care for others, among the members and community building a sense of dignity and belongingness; and
- d) As a Model Organization lives and leads a cooperative anchored in an efficient and productive endeavor ensuring the growth of the members thru an open, liberating and dedicated undertaking by strengthening the cooperative systems, structures and procedures to uplift the social, economic and cultural life and environment of the community.

SJMPC has core values which have an acronym of "I BELONG" which stands for I- intergrity, B- belongingness, E – efficiency, L – loyalty, O – openness, N- nobleness, and G – generosity. Each day we enflesh these core values as we deal with our members and stakeholders who link with us.

It has 7 members sitting in its Board of Directors, 62 Committee members, and 33 regular employees and 2 probationary employees who compose the Management Staff.

It is affiliated with the Antique Federation of Cooperatives and Credit Unions, the San Jose Municipal Cooperative Development Council, and the Antique Provincial Cooperative Development Council.

SJMPC offers the following programs and services: The Cooperative accepts savings and time deposit as its financial products. It also offers loans to members responding to their specific purposes.

Poverty reduction has been SJMPC's goal even during the time of its founder, Msgr. De Wit. He wanted Antiqueños to be out of its brand name as "sakadas" or sugar planters of hacienderos in Negros. We also echo the battlecry of the local government. The Cooperative wanted Antique to be out of the "Club 20" or the top 20 poorest provinces in the country. The following poverty reduction initiatives were implemented by the Cooperative:

- a) Financial assistance to members through low interest loan facility for them to become economically productive in order to create resources for themselves.
- b) The basket loan is made available to members with low income and with ambulant businesses. It started in 2011 and has helped numerous members. It has no other deductions and payments are collected daily.
- c) The Micro-enterprise loan helps members who are engaged in various micro enterprises such as sari-sari stores, bakeshops, beauty parlors, and food and fruit vending.
- d) Agricultural loan helps farmers run their farm more efficiently.
- e) SJMPC teach members to be financially literate by conducting financial literacy sessions and offering them various savings programs like regular savings, ultima savings, alkansya, animators, and time deposits.
- f) SJMPC addresses poverty alleviation by providing the basic need which is shelter for the family. In 2000, SJMPC acquired a lot which was divided into 62 sub-lots. It was inaugurated in 2004 and named as the "SJMPC Ruby Jubilee Village" in line with the celebration of its 40th Foundation Year. Sixty-two (62) families were given the chance to live on a piece of land they can proudly call their own.
- g) Advocating for Environment is also considered by SJMPC as a means of reducing poverty. The cooperative conducted mangrove reforestation in San Pedro and Sitio Durog. We also say No to



Plastic and conduct yearly coastal cleanup with the hope that seas will be teeming with fishes that fishermen may catch more for their families. Urban gardening was also taught to members to supply vegetable needs of the residents of barangay Maybato.

h) Livelihood trainings on fish and meat processing and hog raising helps residents of depressed areas to engage in income generating activities which help develop their skills and augment their income.

SJMPC believes in an adage from former US President George W. Bush: "Education is the key to opportunity; it's a ticket out of poverty." That's why in 2000, we started our Bulig Eskwela Scholarship program with 7 recipients. Financial assistance was provided to qualified children or ward of deserving low income members. To date, a total of 270 scholars have benefited from the program. They are now earning and helping their respective families. They profoundly thank SJMPC for their secondary education.

In 2016, an opportunity was offered to 3 undergraduate SJMPC employees to finish their bachelors' degrees. Two of them are already graduates and are now earning higher salaries

With the aim to help provide a conducive climate for learning, SJMPC joined the yearly Brigada Eskwela Program of the Department of Education by providing assistance during said activity.

In response to the malnutrition problem of the province, a supplemental feeding program is also provided in various schools since 2014 to the present.

Values formation sessions for parents and teachers were conducted for our adopted school – Bongbongan 1 and 2 Elementary School in Hamtic, Antique, and for BES scholars and their parents in order to help them guide their children to become more productive and self-reliant members of the society.

Since 2014 to the present, school supplies are distributed to all students of Bongbongan. In 2016, SJMPC helped in the renovation of their comfort rooms.

SJMPC also sponsors trainings for small cooperatives in the province. To date, fifteen cooperatives have benefited from the program.

The Cooperative believes that being healthy is being wealthy. SJMPC linked with Medicus, Medicpro and VM Medical Supplies for members to avail discounts on their laboratory and medical needs.

The Damayan program of the Cooperative was started in the 1970s with the aim to lessen the burden of the bereaved families. The program has been renamed as GAAN and has helped 38 families giving them a maximum financial assistance of P30,000. SJMPC also partnered with FONUS and bereaved families can now avail P5,000 worth of discounts for wake and funeral services

All these initiatives were considered by SJMPC as effective in increasing the household income of its members because the Cooperative is able to maintain its Portfolio at Risk in single digit for 2 years now. Eighty percent (80%) of members were able to pay their loans on time, thus granting rebates in the amount of P1.7M, P1.9M and P2.2M for 2016, 2017 and 2018 respectively. Deposit Liabilities also increase by almost P30M annually since 2016.

With all these initiatives, programs and activities, SJMPC remains to be financially viable. It continuously gives financial assistance to members. As of today, the Cooperative has granted a total assistance of P429.3M. It is able to implement its developmental and social programs to fulfill its Vision and Mission. For 7 years, SJMPC remains to be debt free or it has no external borrowings and has created 2 satellite offices outside the province.

SJMPC has set a remarkable record in net surplus. In 2016 and 2017, the Cooperative gave members an average of 10% and 14% for dividend and patronage refund respectively which are higher than the interest given by banks.

The awards given by Cooperative Development Authority or CDA exhibits SJMPC's faithfulness in meeting the standards and good practices set by this regulating body for cooperatives in the Philippines

To ensure the sustainability of the cooperative, second liners are prepared for every department, officers and staff were sent to trainings, seminars and conferences for continuing education. Youth programs are designed and implemented such as the annual gathering of children of members where topics about Cooperative, Financial Management, Environmental Care, Values Formation, Personality Development are given.

Effective and Efficient Strategies and Policies are formulated to ensure contribution of members to their share capital which SJMPC considers as the source of its sustenance. In 2017, a creative pakulo was lauched to encourage members to continuously sustain and increase their share capital.

For many years now, SJMPC has been visited by fellow cooperatives, various organizations, agencies and individuals from within and outside Antique which look for programs, projects and activities they could adapt. The triple bottom line reporting, the conduct of midyear and yearend assessment and planning, the unique Ultima Savings Program, techniques and strategies in reducing our Portfolio at Risk (PAR) stir their attention and they articulated to replicate these in their respective organizations. Lastly, they were awed by the climate of belonginess and family spirit to which we adhere as a Christ-centered SJMPC!







Beneficiary is given 12 months form the time of death of the member to claim the benefits, otherwise it will be forfeited.


